


INSTALLATION INSTRUCTIONS

PERMA ADJUSTABLE HEADERS

NOTE: Check all shipping containers before releasing carrier. Notify carrier immediately upon discovering any concealed



pad and add $\frac{1}{2}$ " for clearance, or slide the channels on the bearing wheels and measure the distance between them. This will give you the distance apart the channels will be mounted on the building wall.



Mark the wall so that the header is centered on the door opening.

Normally the channels are to be mounted even with the top of the side pads. Make sure they are square to each other and plumb.

SPECIAL NOTE:

Because of variations between door sizes specified and actual size, channel mounting hardware will be shipped loose for in-field welding.

SIDE PAD HARDWARE

Inside and Outside Mounting

Side Pads up to 10 ft.:

4 angles per pad 8 angles per unit

Flush Mounting


Side Pads up to 10 ft.:

3 angles & 2 flats per pad 6 angles & 4 flats per unit

Side Pads 10 ft. and over:

3 angles & 3 flats per pad 6 angles & 6 flats per unit





Attach mounting hardware to the side pads and install them on the wall with inside edges tight against the channel

- 1. HEAD PAD (1)
 - (1) steel frame
 - (4) bearing wheels
 - (2) pulleys
 - (1) wood backing
 - (1) urethane foam pad
 - (1) fabric cover
- 2. SIDE PADS (2)
 - (1 ea) wood backing
 - (1 ea) urethane foam pad
 - (1 ea) fabric cover

- 3. HEAD PAD CHANNELS
 - (2) channels (to spec. length)
 - (2) stop bolts (top)
 - (2) stop angles (bottom) w/bolts
 - (4) channel mounting hardware (to mounting variation spec.)
- 4. SHEAVE ANGLES
 - (1) left sheave angle
 - (1) right sheave angle
 - (4) 3" sheaves & bolts
- 5. COUNTERWEIGHT
 - (1) counterweight
 - (2) counterweight wire
 - (2) cable clamps


MOUNTING VARIATIONS






Measure from back of the channel $5-\frac{1}{2}$ " toward the center of the door to position inboard end of the left sheave angle.

Measure from back of the channel 10" toward the center of the door to position inboard end of the right sheave angle.
