

### **INSTALLATION INSTRUCTIONS**

### PERMA P-90 FOAM SEAL F-SERIES

NOTE: Check shipping containers before releasing carrier. Notify carrier immediately upon discovering any concealed damage.

- A. At least 4" of protective bumper is required with this unit.
- B. All pads must be mounted with air/water release grommets or screens facing down.
- C. Completed units must be caulked around the entire outside edge.
- 1. Find and mark the centerline of the F-header curtain, the 2" x 4", and the door opening. Depending on the dealer preference; F-headers can come attached to the 2" x 4" at the factory (If the header is attached skip step 5).
- 2. Find the side pad length. Mark the building wall for this height from the dock floor. This mark is the location of the *bottom* of the 2" x 4".
- 3. Match the centerline marks and the height marks. Bolt the 2" x 4" to the wall (bolts are supplied by others). Make sure the *bottom* of the 2" x 4" is flush with the height marks.
- Fasten side pads to wall, making sure they are plumb and even with the bottom of the 2" x 4"
- Match the centerline marks and nail the F-header curtain across the top of the 2" x 4". Using the provided wood screws, fasten stays to the 2" x 4" through the grommets in the header.
- Screw molding strip through Fheader flap into 2" x 4" with #10 slotted hex washer head metal screws.
- Attach F-header end caps by nailing through hemmed edge into the side pad backboards



with # 10 slotted hex washer head metal screws and fender washers (3 each side). Also attach the 1" elastic strap by nailing into side pad backboards (NOTE: Attach at an angle, preferably 45°)

8. If F-header has Velcro slits, attach 2" strap to inside edge of the side pad backboard with roofing nails.






Figure 2: The difference in door width and unit width may require variable mounting of the side pads. The flush mount is shown on the previous page. Mounting brackets are provided, anchors are not included. For the outside mount, bracket may extend into door opening. In this case, either bend over or trim off excess metal.
